**TERMS AND CONDITIONS**

## Trade Gold – Drive Bold Contest Terms and Conditions

**Trade Gold – Drive Bold Contest (herein the “Promotion”) is a reward offered by HF Markets (SV) Ltd (herein the “Company”) to its Clients under the following Terms and Conditions.**

### **1. Introduction**

- 1.1. The Promotion is available to all Affiliates of the Company who have satisfied the Criteria as set out in this Promotion’s Terms and Conditions.
- 1.2. This Promotion is available to the Company’s Affiliates that:
  - a. Have opened a myHF Account with the Company as per the Account Opening Agreement;
  - b. Applied for an Affiliate Account as per the Company’s Affiliate Agreement and must have been approved by the Company as its Affiliate;
  - c. Have completed the age of 18 or the legal age applied in their country of residence or must not be otherwise considered as a ‘minor’ in their country of residence;
  - d. In order for an Affiliate to be eligible in the Promotion, must be a resident of Angola, Benin, Botswana, Burkina Faso, Burundi, Cameroon, Cape Verde, Central African Republic, Chad, Comoros, Democratic Republic of Congo, Djibouti, Equatorial Guinea, Ethiopia, Gabon, Gambia, Ghana, Guinea-Bissau, Ivory Coast, Lesotho, Madagascar, Malawi, Mali, Mauritania, Mauritius, Mayotte, Mozambique, Namibia, Niger, Nigeria, Reunion, Rwanda, Sao Tome and Principe, Senegal, Seychelles, Somalia, Swaziland, United Republic of Tanzania, Togo, Uganda, Zambia, Zimbabwe.
  - e. Have accepted the Terms and Conditions of this Promotion.

### **2. Promotion Period**

- 2.1. This Promotion is offered by the Company to all of its Affiliates from Angola, Benin, Botswana, Burkina Faso, Burundi, Cameroon, Cape Verde, Central African Republic, Chad, Comoros, Democratic Republic of Congo, Djibouti, Equatorial Guinea, Ethiopia, Gabon, Gambia, Ghana,

Guinea-Bissau, Ivory Coast, Lesotho, Madagascar, Malawi, Mali, Mauritania, Mauritius, Mayotte, Mozambique, Namibia, Niger, Nigeria, Reunion, Rwanda, Sao Tome and Principe, Senegal, Seychelles, Somalia, Swaziland, United Republic of Tanzania, Togo, Uganda, Zambia, Zimbabwe.

2.2. The Promotion runs from the 22nd of May 2025 to 22nd of August 2025. The Affiliate enters into this Promotion by accepting the Terms and Conditions.

### **3. Terms and Conditions**

- 3.1. This Promotion applies to new and existing Affiliates.
- 3.2. The Affiliate shall receive 1 point for every new client activated during the Promotion Period.
- 3.3. Additionally, the Affiliate shall receive an extra bonus of 2 points for the Clients that join the Promotion and perform an eligible trade for the Promotion.
- 3.4. Only XAUUSD and XAUEUR are eligible trade for this Promotion.
- 3.5. The points accumulated by the Affiliate may be redeemed for raffle tickets, which shall be used to enter various prize draws as paragraph 4.1.
- 3.6. An Affiliate can win only one Reward as per paragraph 4.1.

### **4. Rewards**

- 4.1. The eligible Affiliates will enter the Lucky Draw and they will have a chance to receive 1 of the prizes as outlined below:

If any of the winners do not respond to the Company within the first week of announcement, then the award will be considered to have been forfeited.
- 4.7. The Company shall consider whether the participants fulfil the requirements specified under these Terms and Conditions and should the Affiliate qualify, the Company will send the applicable award to the Affiliate.

## **5. Termination**

- 5.1. The Company reserves the right to refuse offering the Promotion to any Affiliate of the Company at its sole discretion without the need to provide any justification.
- 5.2. If the Company suspects or has reasons to believe that the Affiliate has submitted fraudulent details and or false identification information during the Account Opening Process, the Company reserves the right at its absolute discretion to disqualify the Affiliate from this Promotion and/or any other promotion and/or contest and/or bonus program offered by the Company.
- 5.3. If the Company suspects or has reasons to believe that any Affiliate has abused and/or manipulated and/or breached in any way any of the Terms and Conditions of this Promotion and/or any other promotion and/or contest and/or bonus program offered by the Company and/or has not acted in good faith, the Company reserves the right at its absolute discretion to (i) void and/or put on hold any payment of the Reward reached by the Affiliate in any given month and/or (ii) completely disqualify the Affiliate from this Promotion and/or any other

promotion and/or contest and/or bonus Program offered by the Company with immediate effect.

- 5.4. If the Company suspects or has reasons to believe that any Client assigned under the Company's Affiliates has abused and/or manipulated Company's internal systems, by hedging his positions internally (using other trading accounts held with Company) or externally (using other trading accounts held with other brokers) and/or has not acted in good faith, the Company reserves the right, at its absolute discretion and without obtaining the Affiliate's consent, to completely disqualify the Affiliate from this Promotion with immediate effect and/or void and/or put on hold any payment of the Reward reached by the Affiliate.

## **6. Amendments**

- 6.1. The Company reserves the right, at its absolute discretion, to unilaterally modify, change or terminate this Promotion or any of the Terms and Conditions included herein, at any time without the Affiliate's consent.

## **7. Dispute**

- 7.1. Any dispute arising with or in connection to any of the terms and conditions of this Bonus shall be dealt by the Company as per the Company's Complaints Handling Policy, which is available on the Company's website.

## 8. Acknowledgements

- 8.1. The Affiliate acknowledges that where the Company has any indication or suspicion of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage connected to a Trading Account or any other forms of deceitful or fraudulent activity, then the Company reserves the right at its sole discretion to:
- Close/ suspend all Trading Accounts the Affiliate has with the Company either temporarily or permanently;
  - Void all previously credited trading bonuses from the Affiliate's Trading Accounts with the Company;
  - Void all transactions carried out, including any pending orders and/ or any profits or losses earned.
- 8.2. Affiliates further acknowledge and understand that where any of the circumstances mentioned in Clause 8.1 above, occur, the Company will not be liable for any consequences on the Bonus cancellation, including, but not limited to, order(s) closure by Stop Out.
- 8.3. The Affiliate hereby acknowledges, confirms and accepts to be legally bound by the Terms and Conditions as set out in this Promotion and/or any other legally binding Agreement between him and the Company.
